

General hygiene regulations of the University of Music and Performing Arts Munich

Last updated on 02/11/2020

The stay in the university buildings or on the university grounds is to be limited to what is absolutely necessary.

For each classroom a maximum number of people allowed in the room is specified. Please refer to the university's website for more information. Groups are taught in rooms that, due to their size, allow for the required minimum distance between all participants. Compliance with this is binding.

Persons are not permitted to enter the university if they

- have contracted COVID-19,
- have symptoms that may indicate COVID-19 disease, such as respiratory symptoms of any severity, unspecific general symptoms and olfactory or gustatory disorders,
- knowingly had contact with a confirmed COVID-19 patient in the last 14 days (contact person category I),
- who are obliged to remain in domestic quarantine for 14 days according to entry quarantine regulation (EQV) currently in force (<https://www.gesetze-bayern.de/Content/Document/BayEQV/true>).

Not covered by the third and fourth option are persons who have a medical certificate in German or English confirming that there is no indication of infection with the coronavirus SARS-CoV-2 and who present it to the personnel department. The medical certificate must be based on a molecular biological test for the presence of an infection with the coronavirus SARS-CoV-2, which was carried out in a member state of the European Union or another state that the RKI has included in its list of states with a sufficient quality standard for this purpose, and which was carried out no more than 48 hours before submission to the personnel department. It should be noted that a so-called "antibody test" is not sufficient.

If you develop symptoms during your stay at the university that indicate COVID-19 disease (such as respiratory symptoms of any severity, unspecific general symptoms and odour or taste disorders), **you must leave the university immediately.**

Minimum distance of 1.5 m: The top priority is to maintain a minimum distance of 1.5 m between persons outdoors and in all rooms, including sanitary facilities, as well as when entering and leaving the premises in corridors, hallways, stairs etc. Regulations regarding greater distances (especially during practice and teaching) remain unaffected by this.

Mouth and nose cover: It is mandatory to wear a mouth and nose cover in corridors, hallways, stairs and all other public areas as well as sanitary areas of the university buildings. This also applies to visitors.

Cleaning and hygiene measures:

Surfaces, such as entrance doors, passage doors, toilet doors, lift buttons etc. are cleaned regularly (at least once a day). The buildings at all university locations are cleaned weekly.

Sufficient washing facilities, liquid soap, disposable towels and hand disinfectants (as an accompanying measure) are provided. Sanitary facilities are equipped with soap dispensers and disposable towels as well as hand hygiene notices.

All members of the university are reminded of the general hygiene rules (regular hand washing, keeping a minimum distance of at least 1.5 m etc.) at the entrance to the building and elsewhere.
